Youth Concerto Competition Application Youth Concerto Competition Policy

1. High School is open to students in 9-12th grade, one winner will be chosen.
2. Middle School is open to students 6-8th grade, one winner will be chosen.
3. Former winners must wait at least 12 months to apply for the same division.
4. Audition spots are available on a first come-first served basis. Once the audition spots are filled, a waitlist will be started and audition applicant will be notified.
5. All applicants should be prepared to play **one movement** of a chosen concerto.
6. The competition is open to all instruments.
7. All auditions will take place before an audition committee.
8. Transportation to or from the audition is not provided.
9. All applications must be complete, including completed application form, letters of recommendation and application fee, and received by published deadline in order to receive an audition opportunity.
10. Application fee is non-refundable.
11. Audition dates, times and location are not negotiable.
12. An alternate audition date will be provided in the case of severe inclement weather.
13. Notification of audition time will be sent by February 11, 2012 via EMAIL..
14. Arrangements for the use of a piano must be noted on the application.
15. Competitors must supply their own accompanist for the audition, if needed.
16. Competitors will be judged on their mastery of their instrument as well as their stage presence.
17. Audition results will be communicated within two week after final audition date.
18. The 1st place winner of the both Middle School and High School will be invited to perform with the Broomfield Symphony Orchestra at the concerts scheduled for May 17th and 19th, 2012.
19. This policy can be amended at any time without prior notice.
20. The decision of the Audition Committee is final.
21. The Audition Committee can decide not to award prizes, if appropriate as determined by the Committee.
