Youth Concerto Competition Policy**

1. High School is open to students in 9-12<sup>th</sup> grade who have not previously won this competition in the high school division. One winner will be chosen.
2. Middle School is open to students 6-8<sup>th</sup> grade who have not previously won this competition in the middle school division. One winner will be chosen.
3. Audition spots are available on a first come-first served basis. Once the audition spots are filled, a wait list will be started and those auditioning will be notified.
4. All applicants should be prepared to play **one movement** of a chosen concerto by memory.
5. The competition is open to all instruments.
6. All auditions will take place before an audition committee.
7. Transportation to or from the audition is not provided.
8. All applicants must be complete, including completed application form, letters of recommendation and application fee, and received by published deadline in order to receive an audition opportunity.
9. Application fee is non-refundable.
10. Audition dates, times and location are not negotiable.
11. An alternate audition date will be provided in the case of severe inclement weather.
12. Notification of audition time will be sent by February 17, 2010.
13. Arrangements for the use of a piano must be noted on the application.
14. Competitors must supply their own accompanist for the audition, if needed.
15. Competitors will be judged on their mastery of their instrument as well as their stage presence.
16. Audition results will be communicated within three weeks after final audition date.
17. The 1<sup>st</sup> place winner of the both Middle School and High School will be expected to perform with the Broomfield Civic Orchestra at the concert scheduled for May 22, 2010.
18. This policy can be amended at any time without prior notice.
19. The decision of the Audition Committee is final.
20. The Audition Committee can decide not to award prizes, if appropriate as determined by the Committee.

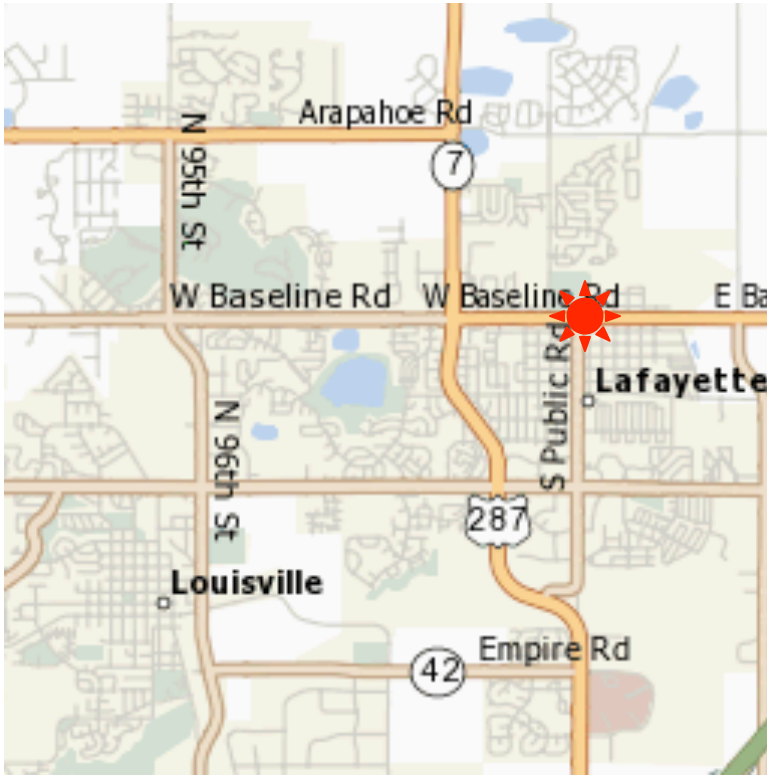
